HURRICANE SEASON: 2022

The 2022 Hurricane Season began June 1st and will run through November 30th. For the 2022 hurricane season, NOAA is forecasting a likely range of 14 to 21 named storms (winds of 39 mph or higher), of which 6 to 10 could become hurricanes (winds of 74 mph or higher), including 3 to 6 major hurricanes (category 3, 4 or 5; with winds of 111 mph or higher). NOAA provides these ranges with a 70% confidence.

We ask that every homeowner and resident of Lago Mar North take the necessary precautions to make our community safer should a storm develop.

A few things to keep in mind when preparing before the storm are:

Prepare emergency evacuations

Make yoursupply checklists and kits

Pet preparedness

Trimming and pruning of trees

Before, During and After a Storm



Prepare your property and reduce the risk of hurricane damage.



Learn how to be ready and hunker down as the hurricane approaches.



Take cautionary measures after the hurricane has passed.

It's easy to overlook safety when you're enjoying summer activities like pool days, cookouts, picnic gatherings, camping trips, and other outings. Some safety tips:

- **Avoid dehydration:** People must always have access to water as they go about their day. Before going outside, make sure to remind everyone to drink at least eight ounces of water. In fact, it's a great idea to hydrate anyway even if they're not going outside.
- **Practice safe swimming:** Make sure everyone stays in groups of two or more when swimming outside, especially the kids. In large areas, children should be guided to always make sure they can see their swimming partners.
- **Summer grilling:** It's best to always have grills at least 6 ft from buildings or trees to avoid the risk of something catching fire. When kids are involved, parents must make sure to adequately supervise them at all times. Close grill lids to avoid flare-ups and cut off the oxygen source of the flame. It's also best to keep a large water bottle or fire extinguisher nearby in case they need to control any flames that arise.
- 4th of July celebrations: Always read directions for use, and only use one at a time. Fireworks should never be handled by children and should never be aimed or thrown at another person. Monitor windy conditions and avoid using fireworks near homes, dry grass, animals, or flammable materials. Proper disposal of fireworks includes dousing them in water before discarding them in an appropriate waste receptacle.
- **Pet safety:** Many pets are afraid of loud noises. Remember to keep your pets safe by leaving them inside to prevent them from running off and encountering harm once the festivities begin.



JUST A FEW REMINDERS...

- Remember to keep your dog on a leash and to properly dispose of their waste.
- Trash bins are collected every Tuesday and Friday and recycling bins every other Friday. Please make sure they are put away once garbage has been collected.
- If you plan on doing any home improvements to the outside of your home, you must submit an ACC form for approval before the work is done. Applications can be found at the end of this newsletter and on the community website.
